**DECLARATION**  
**1- WIFE AND / OR CHILDREN**

(eldest daughter) is still unmarried and I further declare that I am / we are not in receipt of any other pension, that I / we do not hold any situation of profit under the State except:-  
that since the grand of the pension / compassionate allce, my / or private income has not been increased.

I undertake that in case of any of the children of whom pension / compassionate allce is claimed is maint as free or paying Wards, in future, in any of the institution mentioned above, I shall communicate the fact to the pension paying officer and to the Field Pay officer concerned.
